Time: 6 p.m. EDT or at the conclusion of the Chamber Golf Tournament

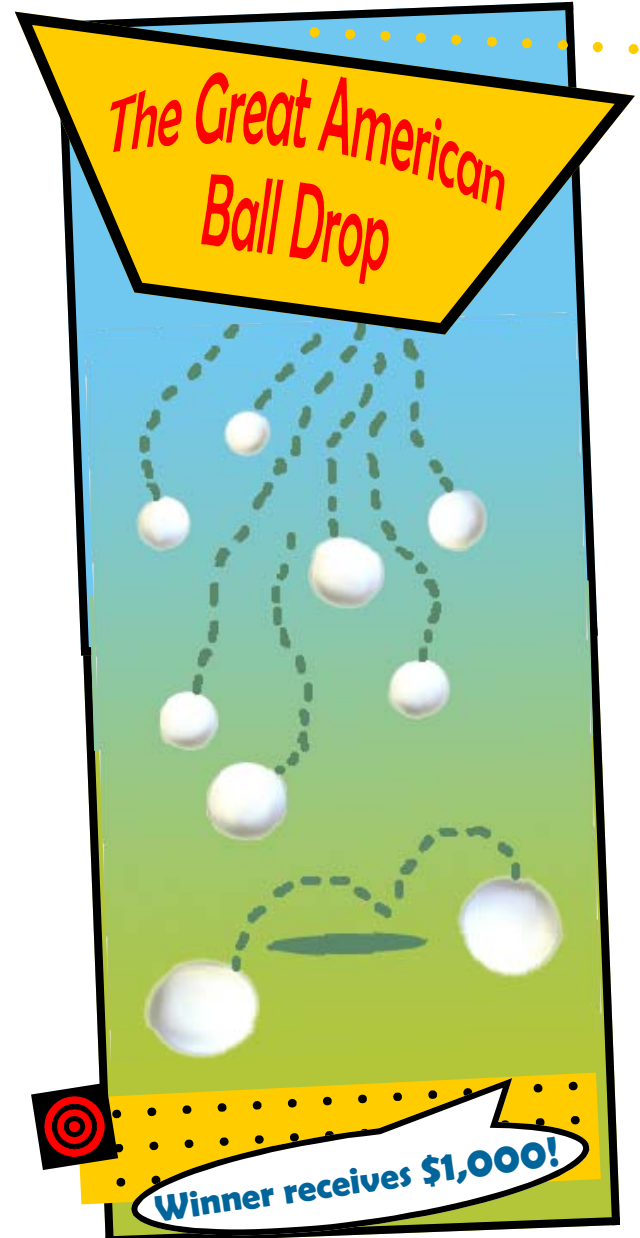
Where: Maple Ridge Golf Club

# Entry Form

## Official Rules & Regulations

The Great American Ball Drop (Ball Drop) is presented by the Greater Columbus Georgia Chamber of Commerce (Chamber).

1. The Great American Ball Drop will take place on May 5, 2006 at the Maple Ridge Golf Club at approximately 6 p.m. EDT.

2. A maximum of 3,000 balls will be entered in the Ball Drop. The odds of winning are contingent on the number of valid entries received.

3. All balls entered will be provided by the Chamber and shall remain the property of the Chamber. Once the balls are dropped, they are on their own. No attempt to free or interfere with any ball is permitted, unless deemed by a representative of the Chamber.

4. \$1,000 prize will be awarded to the ball which falls in the designated hole first or whichever ball is closest to the designated hole. The Chamber and its representative will determine, in its sole discretion, the winner and will award, in its sole discretion, the prize to the winner.

5. A number will be attached to each ball that corresponds with a number that is assigned to each entry form. Multiple ball entries from one entry form will be assigned multiple numbers. The person whose name appears on the entry form corresponding to the winning ball will be awarded the prize. A list of names and corresponding numbers will be posted on the Chamber's website on May 4, 2006: [www.columbusgachamber.com](http://www.columbusgachamber.com).

6. The entry portion of each form must be completely filled out and delivered to the Chamber at 1200 6th Avenue or an authorized representative of the Chamber prior to the deadline; or the entry can be mailed to: Greater Columbus Georgia Chamber of Commerce, P O Box 1200, Columbus, GA 31902-1200 and must be received no later than 5 p.m., May 3, 2006 for an entry to be eligible. Entrants assume the risk of non-delivery of any entries to the Chamber as required under these rules. The Chamber is not responsible for any entries or donations lost in the mail. If any balls remain available after May 3, 2006 for entry in the Ball Drop, the Chamber may, in its sole

discretion, make more ball sales available on May 5, 2006, in advance to the Ball Drop.

7. If the Chamber determines at its sole discretion that the Ball Drop cannot occur at the scheduled time for any reason, then the Chamber can cancel or postpone the event to another date and time by public announcement thereof. The Chamber shall not be held liable in any way for any loss, damage, or inconvenience, which may be caused by any such postponement or cancellation of the Ball Drop.

8. The winner will be announced at the finish of the drop. Entrants do not need to be present to win. Entrants who are not present, who win the prize, will be notified by U.S. Mail or by telephone. If the winner does not claim his or her prize within 30 days of the drop date, the Chamber will select a substitute winner through a random drawing of entry forms. Employees and their families of the Chamber are not eligible to win.

9. Any and all taxes and similar fees are the sole responsibility of the winner. Entrants release the Chamber and its members, employees, supporters, and volunteers involved in the event and completion of the drop, from any and all liability with respect to prizes.

10. By entering, winners consent to the promotional use of their names and likenesses without compensation. This event is subject to all federal, state and local laws and regulations and is void where prohibited by law.

11. The Chamber and the Ball Drop Committee will make all decisions and interpretations of the rules and regulations, and its judgment is final.
